**Introduction (v. 17):**

God's loving mission of redemption is intrinsically \_\_\_\_\_. It is the greatest masterpiece of \_\_\_\_\_ in all of history.

**I. Spiritual Condemnation is the Consequence of Deadly Unbelief. (v. 18)**

**A. Unbelief is a self-condemning \_\_\_\_\_. (18b)**

**What is Condemnation?** To remain under the \_\_\_\_\_ of God under a sentence of spiritual \_\_\_\_\_ (to "perish")

- *Scripture: John 1:10; 3:16; 3:36; 5:26-29*

The difference between the believer and unbeliever does not lie in the guilt or innocence of either; it lies in the different \_\_\_\_\_ they take toward the "light."

**B. Unbelief is a personal \_\_\_\_\_ of Jesus. (18c)**

To not believe in Jesus' name is to reject all that He is:

God (John 1:1)

The Word (John 1:1, 14)

The Creator (John 1:2)

Life (John 1:4a)

The True Light (John 1:4b, 9-10)

Son of God (John 1:14, 16, 34; 3:16)

Lamb of God (John 1:29, 36)

To reject Jesus' name is to reject God's one and only plan for \_\_\_\_\_.

- *Scripture: John 3:14-17; 1 John 1:8-9*

**II. Persistent Unbelief is the Result of a Suicidal Love of Darkness. (v. 19)**

Why does mankind naturally reject God's plan of love and light?

- Is God's plan **unreasonable in its demands**?

**III. Suicidal Love of Darkness Leads to a Passionate Rejection of \_\_\_\_\_.**

**Questions to Consider:**

(Hint: Consider the context)
2. Why is it so significant that verse 18 says the unbeliever is condemned “because he has not believed in the name of the only Son of God.” (v. 18)
3. Why can't a person claim that God's plan of salvation is inapplicable to them, inadequate for them or unreasonable in its demands?
4. Why does mankind naturally love the darkness and evil deeds? (v. 19-20)
5. How does “coming into the light” reveal that our righteousness “has been done through God?” (v. 21)
6. The Puritan John Owen said, “Be killing sin or sin will be killing you.” In what ways might this be true for both the unbeliever and believer?
